THIS AGREEMENT entered into this 27th day of November, 1928, by and between Wilbur Lewis of Rio, Wisconsin and Tollef Landsverk of the same residence.

WITNESSETH: For and in consideration hereinafter named, the said Wilbur Lewis agrees to move the dwelling house from off Lots 4 & 5, Block #2, Buchanans Addition to the Village of Rio (known as the Adeline Brown house) and move same unto the premises on the Tollef Landsverk farm (known as the Grant Gilbert farm) within ten days, if weather conditions are reasonable. The dwelling house to be moved unto the new premises in as good a shape and condition as it was before moving and the said Wilbur Lewis to pay all charges and expences in connection with the moving of such property. It is further agreed and understood by and between the parties hereto that, the house in question is to be deposited on the foundation on premises and if such foundation is not ready or completed at the time the house is moved, the said Wilbur Lewis agrees to move it unto the foundation when completed, and requested to do so by the said Tollef Landsverk, without any further or additional charge.

When the dwelling house is moved and deposited on the above mentioned premises, the said Tollef Landsverk agrees and binds himself and heirs, to give and execute a warranty deed in favor of the said Wilbur Lewis, covering Lots #4 and #5, in Block #2, Village of Rio, Columbia County, Wisconsin. Same being in payment for services and expences of moving the property in question and above described.

It is further agreed and understood, by and between the parties hereto, that if the above described building is not moved and deposited unto the premises above described within ten days from date (weather conditions permitting) the said Wilbur Lewis is to forfeit the \$42.00 deposited in trust with the First National Bank of Rio and also forfeit any and all benefits under within contract.
